The type of personal information we collect

We currently collect and process the following information:

- Personal identifiers, contacts and characteristics (for example, name and contact details)
- We also collect the following voluntarily submitted information related to your participation in the 7000 Humans global initiative.

a. A self-formulated 'commitment'

Your 'commitment' is described up to 50 words. It relates to an action or actions you will undertake during this year. The commitment can relate to one-off actions, or something ongoing; individual and/or collective actions, in the inner invisible and/or outer visible field. It might be a commitment to something new or putting into word something you are already doing. [See website 7000Humans.com for further details about nature of commitment]

b. A description of the action [Up to 50 Words]

c. A description of your tree partner-place / local anchor point on the planet.

You submit up to 30 words to describe your chosen tree/place/anchor point. This is a place where you go regularly or occasionally on your own, or see in your mind's eye, that gives you an anchor point on the planet to reflect on and/or to talk about your commitment and action with others.

d. A question that you think is relevant to our times [up to 50 words]

How we get the personal information and why we have it

All the personal information we process is provided to us directly by you, from the moment of REGISTRATION. The purpose of the information you supply is only collected to enable your full participation in the co-creative global initiative '7000 Humans'

We do not receive personal information indirectly.

The minimal information that you submit about yourself [Name Where you live, without street address, and your tree partner place /local anchor point on the planet that you visit; as well as the Commitment, the Action and the Question] is publicly shared via your own 'personal participant information' section reached via a 'pin' on the global map.

You can add to and amend or delete all or any of this information at any time yourself, via a password that you create in the Registration process.

We do not have access to your 'personal participant information' section.

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

(a) Your consent. You are able to remove your consent at any time. You can do this by contacting info@7000humans.com

(b) Your consent is needed to create this public participatory initiative in which you have chosen to participate.

(c) We have a legitimate interest.

How we store your personal information

Your information is securely stored on a server supplied by Digital Ocean and located in the UK.

We will keep the information outlined above for the duration of the 7000 Humans initiative. This is until 31 January 2023. We will then dispose of your information by deleting it completely from the server and therefore also from the website. If the project continues beyond 31 January 2023, you will be informed and be able to withdraw all your information from the website's server. It will also not be archived if you do not agree to this. A request for archiving all or aspects of the material submitted by participants for public display will be made before the end of January

2023, if the initiative is going to become an archival document, or if there are any other forms of continuation. At all times you will be able to withdraw your submitted information without giving any reasons.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information, although this will be visible to you throughout the initiative, via the MAP section of the 7000 Humans.com website.

Your right to rectification - You have the right to amend your personal information yourself, using your own self determined password.

Your right to erasure - You have the right to erase your personal information at any point, with no explanation, using your own self determined password.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
